Cabinet Decree No. (131) of 2023 Concerning Export Fees for Industrial Waste

The Cabinet;

- Having reviewed the Constitution; and
- Federal Law No. (1) of 1972 on the Competence of Ministries and Powers of Ministers, as amended; and
- Cabinet Decree No. (20) of 2020 on Service Fees Provided by the Ministry of Economy, as amended; and
- Cabinet Decree No (118) of 2023 on Controls of Industrial Waste Management Policy; and
- Based on the Proposal of the Minister of Finance, as approved by the Cabinet,

Hereby decrees:

Definitions

For the purpose of applying the provisions of this Decree, the following words and expressions shall have the meanings assigned thereto, unless the context otherwise requires:

- **State:** The United Arab Emirates

Cabinet Decree No. (119) of 2023 Concerning the Violations and Administrative Penalties levied on Violators of Cabinet Decree No (118) of 2023 on Controls of Industrial Waste Management Policy

- **Minister:** The Minister of Economy
- **Ministry:** The Ministry of Economy
- **Committee:** Industrial Waste Management Committee.

Article (2)

Export Fees for Industrial Waste

The Ministry shall collect export fees for industrial waste as specified in the table attached to this Decree, at the rates indicated for each type.

Article (3)

Amendment of Fees

The Cabinet holds the authority to amend the fees stipulated in this Decree, whether by addition, deletion, or amendment.

Article (4)

Collection of Fees

1. The Ministry shall collect the fees outlined in this Decree through methods determined by the Ministry of Finance.
2. The revenue from these fees shall be distributed between the federal government and the local governments according to the ratio stipulated in the Cabinet Decree on Industrial Waste Management Policy.

Article (5)

Repeals

Cabinet Decree No. (119) of 2023 Concerning the Violations and Administrative Penalties levied on Violators of Cabinet Decree No (118) of 2023 on Controls of Industrial Waste Management Policy

The service for the export of steel scrap is hereby removed from the service fee table attached to Cabinet Decree No. (20) of 2020.

Any provisions contrary to or inconsistent with this decree are hereby repealed.

Article (6)

Publication and Enforcement

This Decree shall be published in the Official Gazette and shall come into effect thirty (30) days from the date of its publication.
